# ROBERT L. JOHNSON

#### Founder & Chairman of the RLJ Companies; Chairman, Retirement Clearinghouse

Mr. Robert Johnson is the Founder and current Chairman of RLJ Companies, an innovative business network that provides strategic investments in a diverse portfolio of companies including private equity, financial services and asset management. He is very well known for founding *Black Entertainment Television* and he is a media magnate, hugely successful entrepreneur, and a philanthropist.

Perhaps not as well known is his tireless work calling attention to the wealth gap between white and black Americans and his advocacy for asset building in the minority community. In 2012, he unveiled a 5-point policy initiative 'Economic Empowerment in the Black Community,' that would encourage investment in black businesses, alleviate tax burdens and encourage retirement savings for low and middle-income families, and stop abusive payday loan practices. He has continued to advocate for economic justice in policy arenas and on Capitol Hill.

But he is not content to simply advocate. He lives his ideals. One of his many outstanding initiatives is the Retirement Clearinghouse (RCH)—the leading specialist in employee retirement job changer services, with best practices designed to improve outcomes for retirement plan sponsors, participants and providers. RCH's programs increase plan assets, improve plan efficiency, lower plan costs and reduce fiduciary risk while providing participants with beginning-to-end assistance in the complex process of consolidating and managing their workplace retirement accounts. This one project alone was complicated and highly technical but also visionary. RCH has streamlined more than 10,000 sponsor plans, helped more than 625,000 participants, guided billions of dollars in transactions, and reduced retirement plan cash-outs. To put it in simpler terms, the effect was to launch the auto-portability model that ensures that 401(k) retirement savings automatically move with workers for decades to come.

Robert Johnson is that rare combination of a thought leader with an action plan—innovating and actively paving the way for opportunity so that others may succeed as well. We are pleased and proud to honor Robert Johnson with the WISER Hero Award.

## THE HONORABLE PATTY MURRAY

#### **United States Senate, Washington State**

From the day she arrived in Washington 24 years ago as a "Mom in tennis shoes" Senator Patty Murray has been a groundbreaker and fierce advocate for women and families. She was the first female Senator from the state of Washington, the first woman to Chair the Senate Veterans Affairs Committee and also the first woman to chair the Senate Budget Committee.

But, her ambitions are not for herself. Her bold dream, in her own words, is to "build the most robust middle class the world has ever seen." And her current position as ranking member on the Senate Health, Education, Labor and Pensions Committee, gives her a position of great influence to continue to do so.

Coming from a solidly middle class background, Senator Murray experienced first-hand the struggles of many Americans. Her father— a veteran and Purple Heart recipient—became disabled and her mother had trouble earning enough to support a large family. Veterans health benefits helped care for her father, a federal program enabled her mother to go back to school and get a better job and federal student loans helped the Senator and her six siblings get a college education. With these struggles in mind, Patty Murray has always been faithful to her promise to work to preserve and build upon programs that lift up the middle class.

Her hometown newspaper has rightfully called her "a workhorse, not a show horse" and we agree. Not many Senators have worked as hard and achieved as much on behalf of hard working middle-class Americans as Senator Murray. Her willingness to work across the aisle, to remain fiercely focused on the challenges we all face in life and finding solutions has led to an impressive list of accomplishments.

We are particularly grateful for her work in improving pensions and access to retirement programs, particularly for women, creating important spousal protections in defined contribution retirement plans, blocking cuts to Security and working to enhance Social Security benefits for spouses and children of deceased or disabled workers.

Her victories are many and span education, health care, pensions, retirement and jobs programs. In each area, and with each legislative effort, Senator Murray painstakingly works to build a strong middle class in America. She creates pathways of opportunity for working Americans and an improved safety net for those experiencing hard times.

## THE HONORABLE PAT TIBERI

#### United States House of Representatives, 12th District of Ohio

Congressman Tiberi was elected to Congress from the 12th District of Ohio in 2000. Since then, he has developed a reputation among his colleagues in the House as a hard-working and skilled legislator. He has been rewarded for his skill and hard work with a position on the House Committee on Ways and Means where he takes a leadership role on important issues that we all care about, including taxes, retirement, housing, Social Security, Medicare, and health care. He serves as Chairman of the Subcommittee on Health and is a member of the Tax Policy Subcommittee. He is also the vice-chairman of the Joint Economic Committee where he shapes the discussion on national economic policy.

WISER is part of a broad community of organizations grappling with ways to strengthen services and help for family caregivers. Congressman Tiberi has been a welcome and effective partner in those efforts. Notably, Mr. Tiberi wrote and helped pass the Older Americans Reauthorization Act of 2006, which funds social and nutritional programs for the country's seniors that help individuals stay in their own home rather than move to institutional care, while improving their quality of life. Congressman Tiberi also worked hard on legislation to make federal assistance more widely available to caregivers of Alzheimer's disease patients. His work on this issue earned him the "Giving from the Heart" award from the Alzheimer's Association – Central Ohio Chapter.

Strengthening local communities for those in need has also been a particular focus for Mr. Tiberi. He led the effort to extend tax provisions that increase investment in community development and affordable housing. His bill, the New Markets Tax Credit Extension Act, laid the groundwork for a five-year extension of this tax credit to attract private capital to some of the most distressed communities in the country. Additionally, he introduced a bill that was signed into law that provides a permanent floor for the Low Income Housing Tax Credit, which spurs investment in affordable rental housing projects and boosts the availability of affordable housing. Many Americans of limited means, including older women, have a safe and affordable home as a result of his outstanding efforts.

The Congressman's thoughtful approach to services for older Americans coupled with skilled legislative work has made life healthier and more secure for older Americans everywhere. We are pleased to honor him today with the WISER Hero Award.
